This Contract is for the three days the music festival is operating this year only and does not give vendor any rights for the following year. Bringing vendors back is solely at the discretion of the event organizers. From time to time line up and vendor changes are made to keep things fresh. All approved vendors must be on site by noon on the Friday of the music festival to receive their locations and be placed in line up. Once placed concession must remain in position until the day following the end of the festival.

WHEREAS Event Organizers will hold its annual Music Festival on the grounds of Hilah Ayers Wilderness RV Park, Mulhurst Bay, Alberta.

NOW THEREFORE THIS INDENTURE WITNESSETH that in consideration of the mutual covenants herein contained, the parties hereto agree as follows:

## FOOD VENDOR'S OBLIGATIONS:

- 1) The vendor agrees to set up, operate, and dismantle its food operation in the location determined by Hilah Ayers and assumes all costs for it.
- 2) The vendor agrees that no food items or non-alcoholic beverages shall be sold without the written consent of Hilah Ayers.
- 3) The vendor agrees to operate his/her food booth for the hours during the Festival dates to be specified by Hilah Ayers. Vendors that do not follow this rule will be seen as having breached their contract and will be expelled from the grounds without refund.
- 4) The vendor agrees to maintain the premises it occupies in a clean and orderly condition. Food containers and other litter on the premises occupied by vendor shall be removed as soon as practical during each of the days vendor is operating his or her food booth, and at the end of each day at his or her own expense.
- 5) The vendor must rigorously maintain all Board of Health standards and regulations. Breaches of any health regulations shall result in the immediate expulsion of the vendor, and Hilah Ayers nor the Pigeon Lake Music Festival will not be required to refund any monies to the vendor.
- 6) The vendor will be responsible for obtaining and paying for all necessary permits, licenses, insurance and any inspections that may be required.
- 7) The vendor shall, upon signing this agreement, provide a full menu complete with prices of the requested foods and beverages to be sold, color picture of the unit, statement of outside dimensions (including tongue) and hydro requirements, proof of \$1,000,000 liability insurance protection, naming Hilah Ayers Wilderness RV Park. This is mandatory.
- 8) Soft drink cans will not be sold less than \$2.00, bottles \$3.00 and water \$2.00. This will be monitored so please adhere to this rule.
- 9) The vendor shall bear full responsibility for its trucks and trailers and shall park in areas designated by Hilah Ayers. House trailers that are allowed on the grounds will pay an additional \$120.00 for the weekend.

10) Without restricting the generality of the foregoing the vendor shall comply with all County and Provincial regulations concerning all food concessions together with Hilah Ayers' regulations concerning food concessions. Vendors must produce current AHS certificate to prove compliance before being placed. Any vendor not in compliance will not be placed and will forfeit their concession fee. Re-inspection is required every year.

11) In consideration of the right given to it by Hilah Ayers to sell food items and non-alcoholic beverages and retain the profits of such sales for its own benefit, the vendor agrees to pay Hilah Ayers the sum of \$500.00 \*. The payment of \$500.00 or more shall be made upon submitting the Application.

12) This Agreement shall not be assignable by the vendor without the consent in writing of Hilah Ayers. The Organizing Committee will review all vendor applications and decide which ones to accept. There may be more applications than Hilah Ayers can accommodate.

13) The vendor agrees to collect from patrons and remit to the government the Government Sales Tax (GST) when and where applicable.

An NSF cheque will forfeit your right to be a vendor in the festival and subject to a \$35.00 service charge.

## HILAH AYERS' OBLIGATIONS:

14) Hilah Ayers shall provide to the vendor locations designated in their sole and unfettered discretion.

15) Hilah Ayers covenants to supply the vendor with 15 amp electrical power and water as required by the vendor.

16) Hilah Ayers and the vendor agree that the vendor shall sell the items outlined in the supplied menu, which have been approved by Hilah Ayers.

Electricity will be provided for the vendors' locations commencing on Friday upon setup and be continuous through Sunday (3 days).

\*Bring long enough hose and electrical extensions.
